### How long will this take and key stages?

• Identifying estate property, establishing a summary of the deceased's assets as at the

date of death including a valuation of the deceased's assets and liabilities for estate and tax purposes and preparing the appropriate HMRC inheritance tax account: 3-6 months from instruction

- Establishing the basis for testamentary or other dispositions, preparing the relevant Oath for the personal representatives and submitting the application for the Grant to the Probate Registry of the High Court: 3-6 months.
- Collection of estate assets, payment of estate liabilities and testamentary legacies and distribution of residuary estate: 6-9 months.
- Estate accounts and income tax reports and returns: 6-12 months

# **Private Family and Children Matter**

We are a Legal aid providers in family and childcare law. However, if you do not qualify for legal aid, we charge hourly rates for advice, assistance and representation in privately paid for family matters. Our charge out rates are as follows:

- Senior Solicitor and Director Chargeable Hourly rate: £250 plus VAT
- Associate Solicitor Chargeable hourly rate: £220 plus VAT
- Assistant Solicitor Chargeable hourly rate: £190 plus VAT
- Trainee Solicitor Chargeable hourly rate: £165 plus VAT

In general, costs are likely to be as follows:-

- For a straightforward divorce, it is unlikely that the total costs will be less than £3000 plus VAT and the costs will be more if there are problems with the other person cooperating or if the divorce is contested. The Court fees are currently £593.00 to issue the petition.
- In domestic violence injunctions, when two Court hearings are required, depending on whether it is easy to serve the other person with the Court documents, it is unlikely to cost less than £4,000.
- If there is a dispute about where children are to live and/or how often one parent is to see the children, and the case proceeds to a final hearing without an agreement being reached, the total costs are unlikely to be less than £8,000. A complex case may cost even more. If the case settles at an early stage, the total costs are much less.
